Separate individual sachets from set.



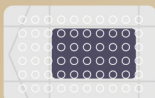
To **ACTIVATE**, peel away foil seal. **DO NOT PIERCE OR PUNCTURE** perforated membrane.



Place sachets in or amongst clothing to be protected coloured pad side up. Please see opposite side panel for typical application rates.



Replace when **RENEW** Indicator shows 'END', which usually appears after 3 month*. *Dependent on area, temperature and airflow.



Please use all year round to be sure of complete protection of your valuables.

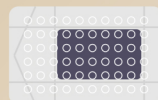

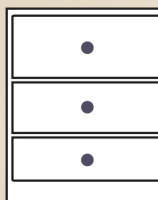

Sachet Clothes Moth Killer and Freshener

The active sachet is individually sealed in a special ventilated material, which controls its diffusion to give consistent performance, whilst avoiding any direct contact with clothes or hands. Each sachet will cover approximately 0.15 – 0.40 cubic metres. It is recommended to use 1 sachet per hanging garment or 2 sachets per drawer.

Each sachet lasts up to 3 months*, is individually foil sealed and has an end of life indicator, to confirm in real time when it must be replaced.
