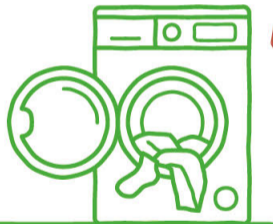

Instructions: The inside of the cap is a measuring cup. On the inside of the cap you'll see measuring rings with a measuring scale. While filling the cup, shake it occasionally to level out the powder, so you can measure the correct dosage. Use the normal amount of your main detergent. Fill the measuring cup with HG eco laundry booster against odours up to the 25 ml measuring ring. Add this amount to the main detergent in the main detergent tray. If laundry smells particularly unpleasant, a double dose can be added to the main detergent. Use: sufficient for around 16 washes

Caution: Read the instructions before use. Always comply with the care label in your clothing. Do not mix with bleach. Only use this product on colourfast fabrics. In case of doubt, check the fabric for colourfastness in an inconspicuous place (e.g. the inside of a hem). Check this by applying a solution of the product (1 teaspoon in 0.5 litres of water) and letting it dry. Do not use on wool or silk. Wear suitable gloves if you have a sensitive skin.
